## Cookies

Joan's Vitality Solutions only uses technical and functional cookies. And analytical cookies that do not infringe on your privacy. A cookie is a small text file that will be saved on your computer, tablet or smartphone when you visit this website for the first time. The cookies we use are necessary for the technical functioning of the website and your ease of use. They ensure that the website works properly and remember, for example, your preferences. They also enable us to optimise our website. You can unsubscribe from cookies by configuring your internet browser in such a way that it no longer saves any cookies. In addition, you can delete all information previously stored using your browser settings.

## Reviewing, modifying or deleting data
